Competition Notice and Regulations

The Pisan Choral Society and LN Promotion Arts Management
with the patronage of the Province of Pisa and the Municipality of Pisa

ANNOUNCE

The 10th Edition of the International Competition "City of Pisa - Tribute to Titta Ruffo" for Opera Singers.

The competition is aimed at the enhancement of young talents in the opera and vocal symphonic, both self-taught and privately students, and to the students enrolled in the upper course of Singing (third, fourth and fifth year of the traditional Singing Course or Specialized two-year course for Italy) of Conservatories and Equalized Musical Institutes Italian and foreign

Art. 1

Singers of both sexes, belonging to any nationality and vocal register, are admitted to participate

- Category A for singers born after 1st January 1994 and before 1st October 2002,
- Category B for singers born after January 1st 1981 and before December 31st 1993

Art. 2

The Competition is a competition with prizes; the awards consist of Concerts with Orchestra, Recital with piano, scriptures and / or auditions in opera houses, scholarships e Advanced Master Class and a cash prize for the most deserving Baritone (regardless of whether he is enrolled in category A or B).

Art. 3

Competitors will be required to present two pieces taken from operas by Classical and Romantic repertoire, of their choice. The pieces must be performed by heart, in the original language and key and must include any recitatives, arias and cabalettes (where required).

Art. 4

Applications for registration, drawn up on the appropriate form (registration form), must be sent, exclusively by e-mail, to the Competition secretariat, at the address segreteria@concorsoittaruffo.it no later than November 5, 2021.

The application must be accompanied by the following documentation:

- a) Copy of any document certifying the date of birth, nationality and residence;
- b) A telephone number and an e-mail address
- c) Artistic-professional curriculum vitae typed in a single folder;
- d) 2 photographs, one of which is portrait format;
- e) Indication and copy in PDF format of the scores of the four musical pieces presented (two for the preliminary round, two for the final phase), in the original language and complete with recitative and cabaletta (where applicable);
- f) Receipt proving the payment of the registration fee of € 50.00 (fifty, 00 - excluding bank charges) for category A and € 65.00 (sixty-five, 00 - excluding bank charges) for category B by paying into the bank account of the

g) g) At the same time as the application for registration to the Competition, the recordings of the two selected pieces must be sent via the WeTransfer platform or link to Youtube, to the address segreteria@concorsotittaruffo.it. The videos must have a maximum total duration of 20 minutes, and must contain the candidate's declaration before the competition test: "Name and Surname, Age, Category A or B, Registration for the 10th Edition of the International Competition for opera singers "City of Pisa - Tribute to Titta Ruffo", be filmed in full length, have good audio quality and have not been subjected to post production editing. If the videos do not correspond to the previous requirements, the competitor will not be admitted to the test.

Art. 5

Competitors admitted to the final round will be informed by publication on the website www.concorsotittaruffo.it on November 13, 2021. The list of winners of the competition will be published on November 21, 2021. The winners will be contacted by email by the Competition secretariat. Each member of the commission may freely and unquestionably assign his prize in Artistic Writings, Auditions, Scholarships and Specialization, to the participant of his choice.

The Commission's judgment is final and unquestionable.

Art. 7

The winners and finalists will receive a Diploma of participation.

The Commission of selection may decide not to assign scholarships and theatrical writings if there are no candidates deemed worthy.

The Commission will not be able to announce ex-aequo winners.

Art. 8

Winners of prizes or writings are obliged to include in their artistic curriculum the writing and / or recognition obtained following participation in the "City of Pisa" International Competition for Opera Singers - Tribute to Titta Ruffo.

The videos of the winners may be broadcast by radio and television broadcasters, according to provisions that will be established, unilaterally and unquestionably, by the Artistic Direction of the Competition.

Art. 9

Each competitor, by signing the application for registration to the Competition, undertakes to accept all the provisions contained in this Announcement and Regulations, as well as the procedures for carrying out the tests and the judging criteria of the Judging Commission.

It is the faculty of the Organizing Committee of the Competition to make any changes to the composition of the Judging Commission that will be necessary for reasons of force majeure.

The Court of Pisa is competent for any disputes.

For any dispute, the Italian version of this Announcement will prevail.
